- VI. <u>Item</u> -- DISCUSSION AND VOTE TO APPROVE OR NOT APPROVE THE 2021-2022 ESTIMATE OF NEEDS.

<u>Information</u> -- The Estimate of Needs is for the 2021-2022 year. The document is for approval of \$22,579,368.70 for General Fund, \$3,544,959.47 for Building Fund, \$1,792,001.62 for Child Nutrition Fund, and \$852,215.10 for the Sinking Fund.

<u>Recommendation</u> -- The board approve the Estimate of Needs for 2021-2022.

VII. <u>Item</u> – DISCUSSION AND VOTE TO ACCEPT OR NOT ACCEPT THE LOWEST RESPONSIBLE BID FOR THE RENOVATION OF THE BOB LEE KIDD CENTER.

<u>Information</u> – We have received bids for the renovation of the Kidd Center. The lowest responsible bid is from **Beshears Construction**. The renovation will be funded entirely with federal stimulus funds at a base Bid of \$2,200,000.00.
